## **CHULA VISTA GOLF COURSE - LOCAL RULES**

**USGA R**ULES APPLY EXCEPT AS MODIFIED BY THE FOLLOWING LOCAL RULES:

- 1. Maintenance roads on the left side of holes #5, 13 and 18 are integral parts of the course. Play the ball as it lies (Rule 28). All other dirt power cart paths are immovable obstructions and relief shall be given under Rule 24-2b.
- 2. For all play at this course, a player may obtain distance information by use of a distance-measuring device. If, during a stipulated round, a player uses a distance-measuring device to gauge or measure other conditions that might affect his play (e.g., elevation changes, wind speed, etc.) the player is in breach of Rule 14-3.
- 3. Stones in bunkers are movable obstructions (Rule 24-1 applies).
- 4. A ball striking overhead power lines on Holes 13 and 16 must be replayed without penalty.
- 5. If there is doubt whether a ball is in or is lost in a water hazard or lateral water hazard, the player may play another ball provisionally under any of the applicable provisions in Rule 26-1. If the original ball is found outside the water hazard, the player must continue play with it. If the original ball is found in the water hazard, the player may either play the original ball as it lies or continue with the ball played provisionally under Rule 26-1. If the original ball is not found or identified within the five-minute search period, the player must continue with the ball played provisionally.

- 6. Dropping Zones: If a ball is in or it is known or virtually certain that a ball that has not been found is in the hazard behind the putting green on Hole 3 or in the area right of the putting green on Hole 4, the player may: (i) proceed under Rule 26-1; or (ii) as an additional option, drop a ball, under penalty of one stroke, in a dropping zone.
- 7. Accidental Movement of a Ball on a Putting Green: Rules 18-2, 18-3, and 20-1 are modified as follows: When a player's ball lies on the putting green, there is no penalty if the ball or ball-marker is moved by the player, his partner, his opponent, or any of their caddies or equipment. The moved ball must be replaced as provided in Rules 18-2, 18-3, and 20-1. This Local Rule applies only when the player's ball or ball-marker lies on the putting green and any movement is accidental. Note: If it is determined that a player's ball on the putting green was moved as a result of wind, water or some other natural cause such as the effects of gravity, the ball must be played as it lies from its new location. A ball-marker moved in such circumstances is replaced. You are responsible for any injury to people or damage to property caused by your actions, including errant golf shots.
